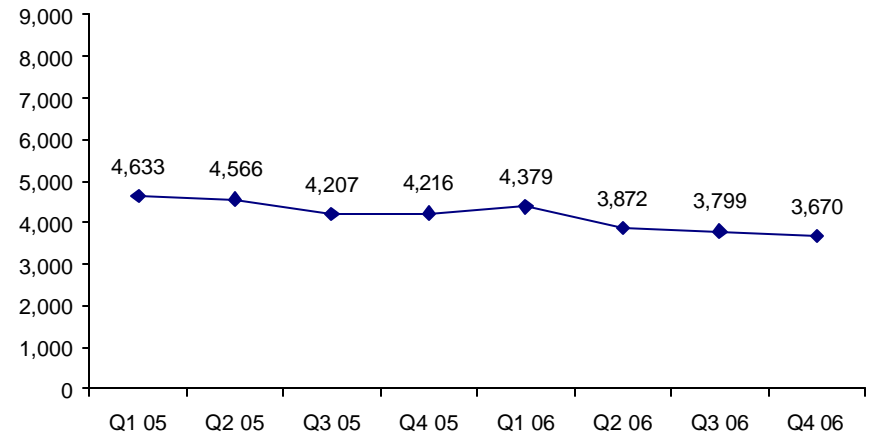

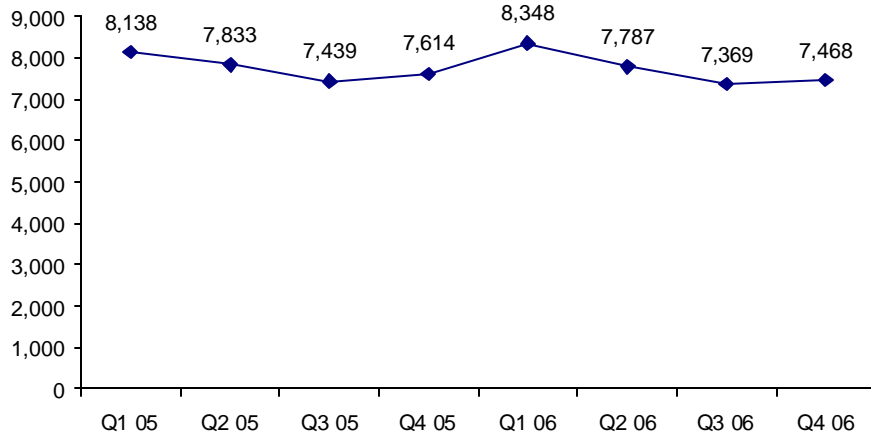

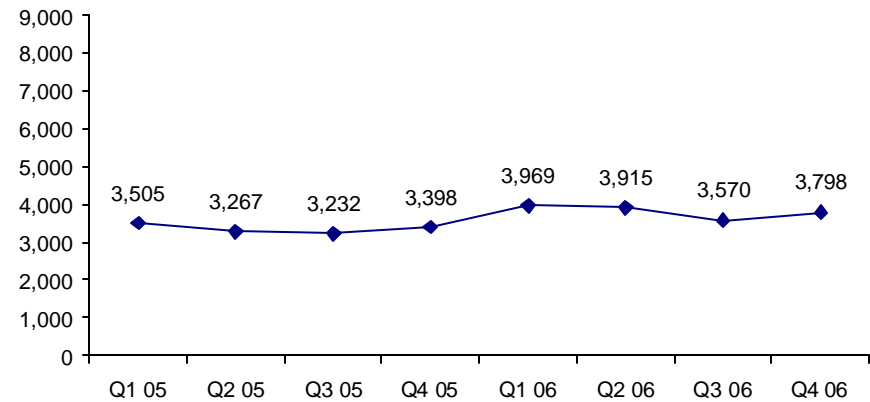
Accepted Reports

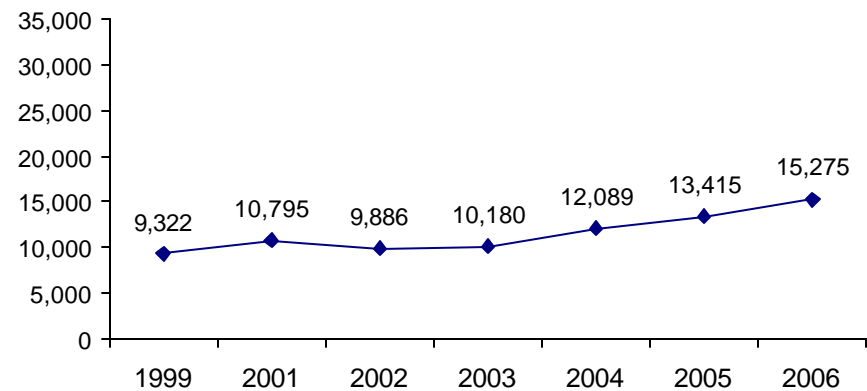

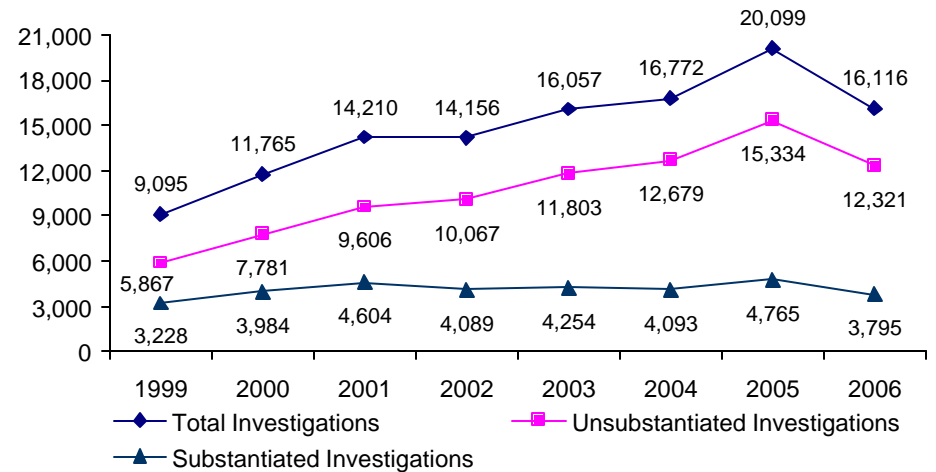

CPS Investigations Percentages (Annual) 1999 - 2006 CY

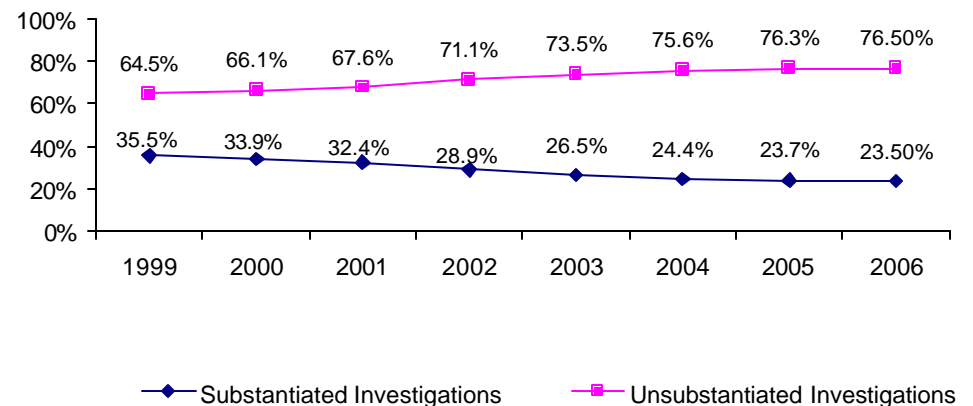
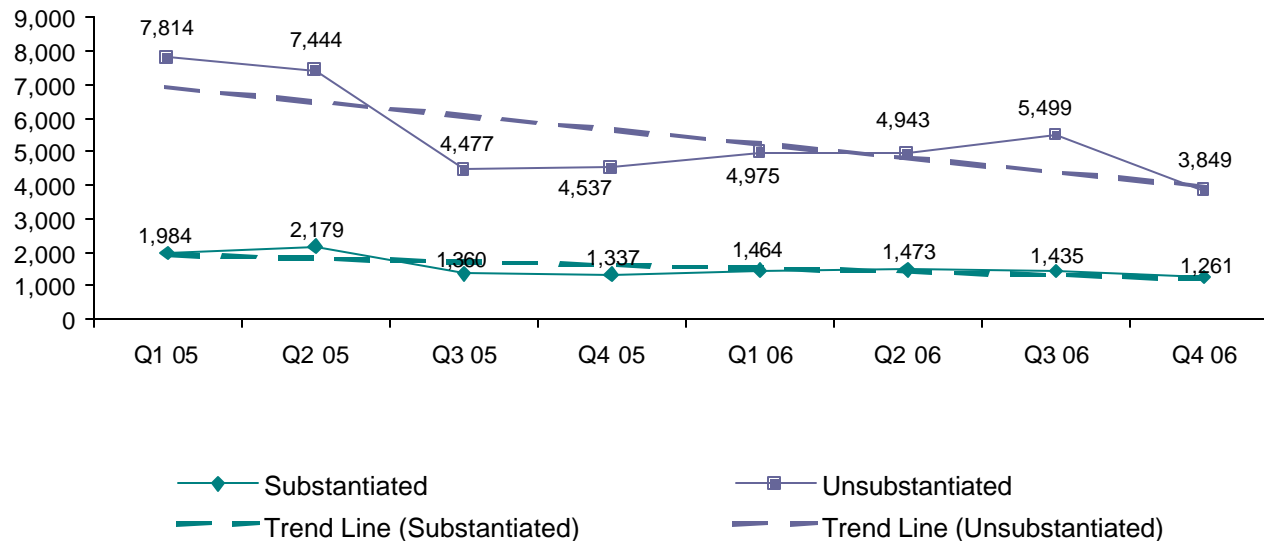

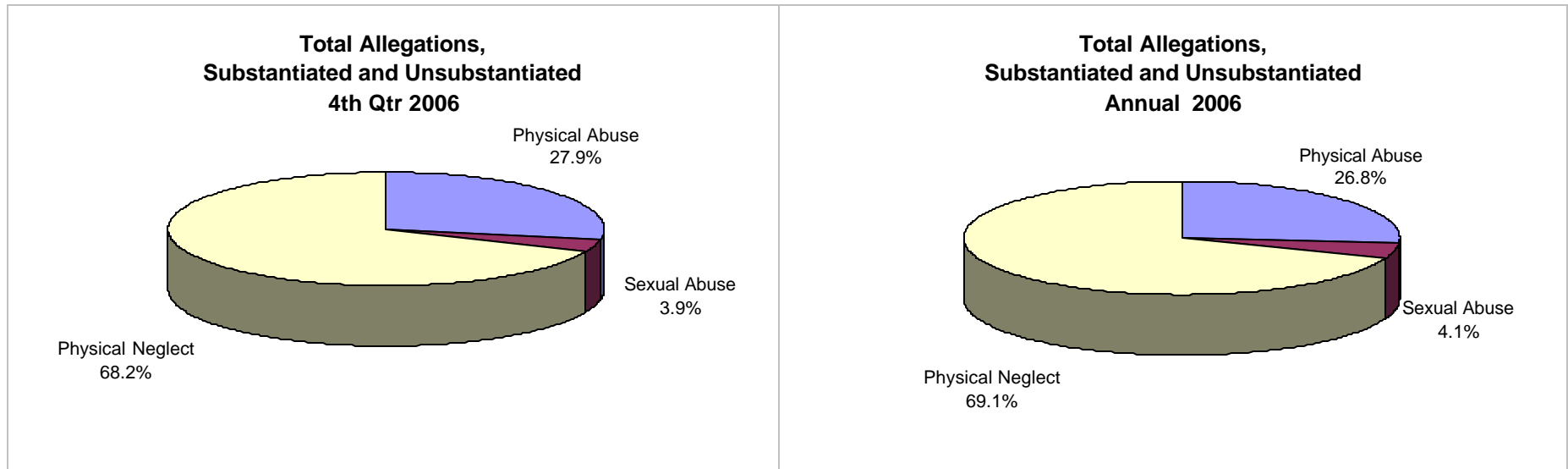

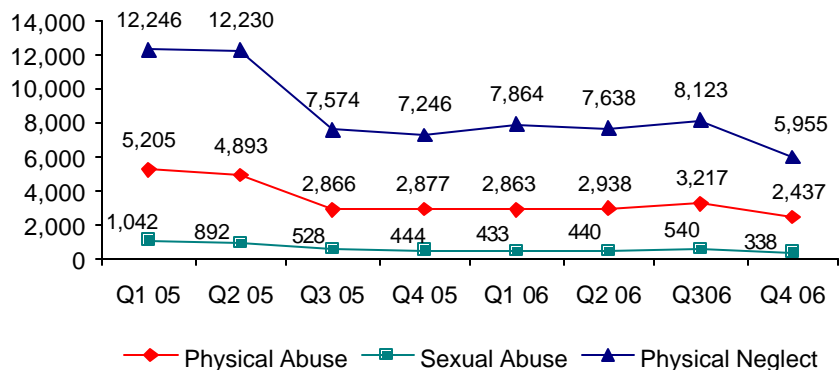

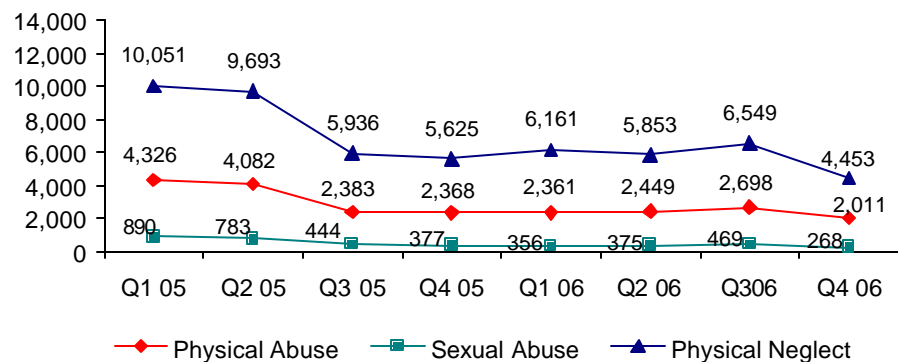
CPS ALLEGATION TYPE RESULTS ¹ (QUARTERLY)

JANUARY 2005 – DECEMBER 2006

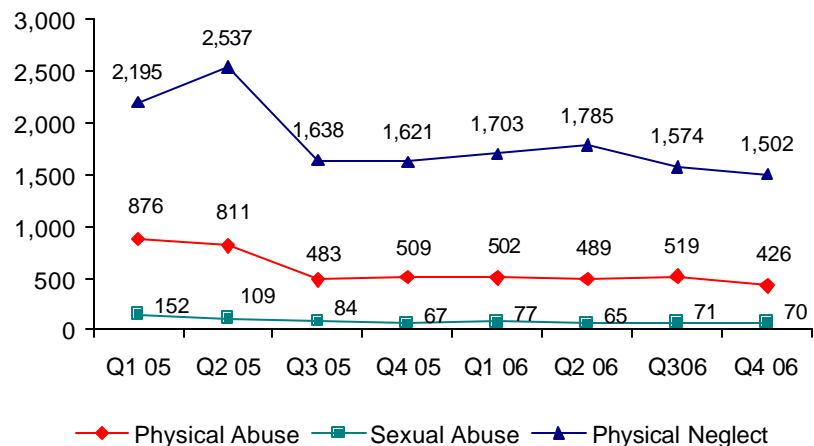
Total Allegations

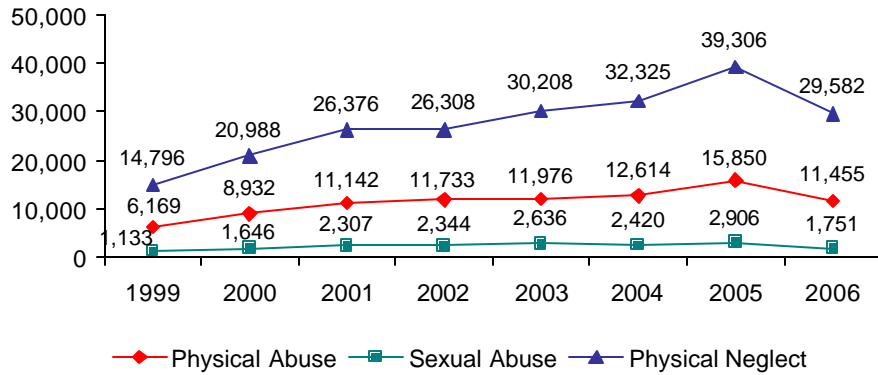

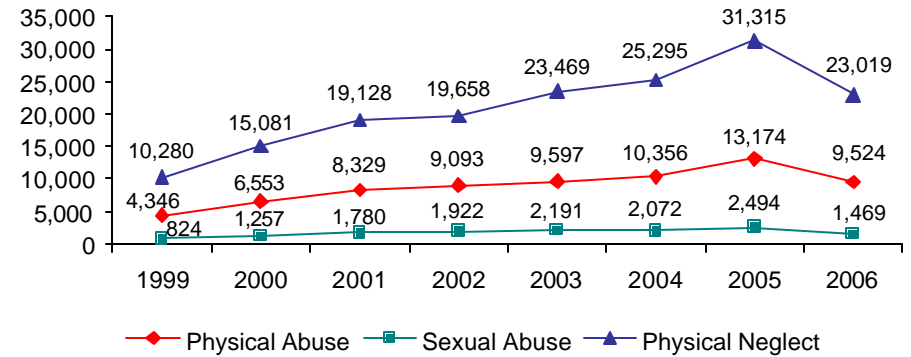
CPS ALLEGATION TYPE RESULTS ¹ (ANNUAL)

CALENDAR YEAR 1999 - 2006

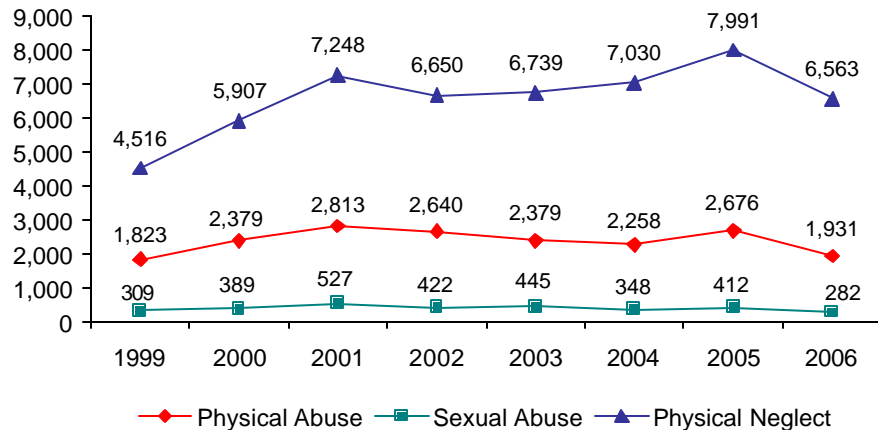
Total Allegations

Substantiated Allegations

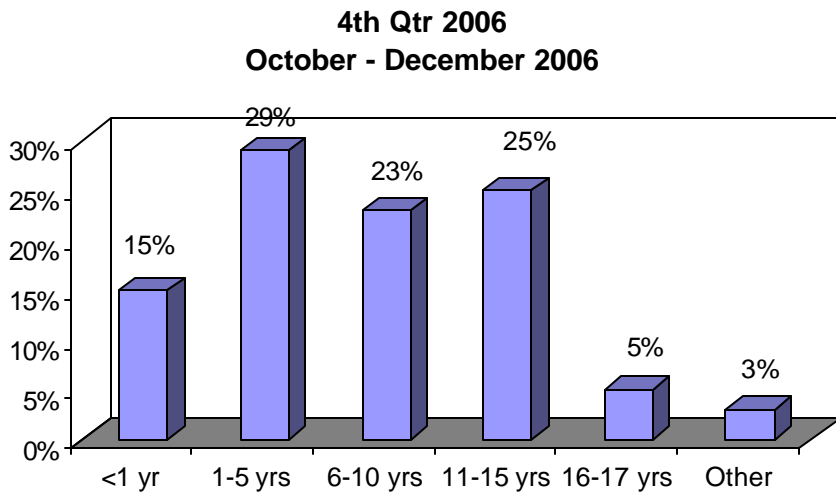

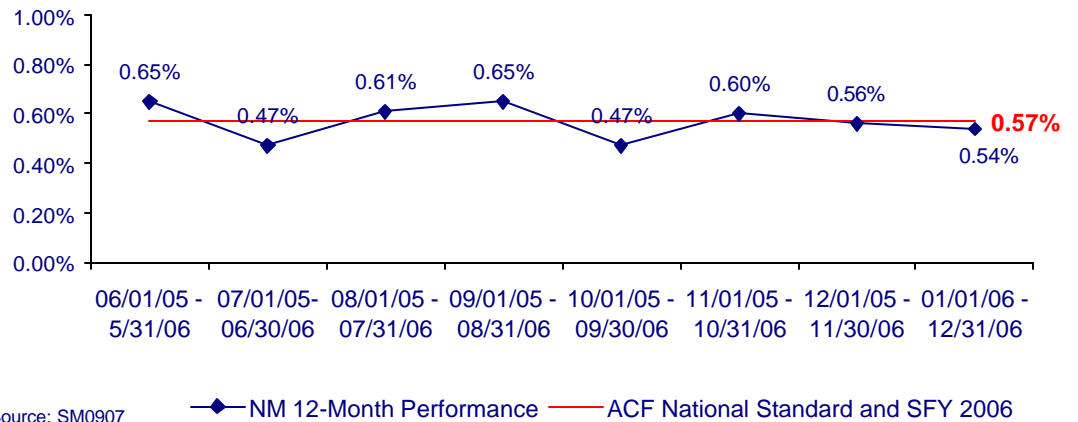

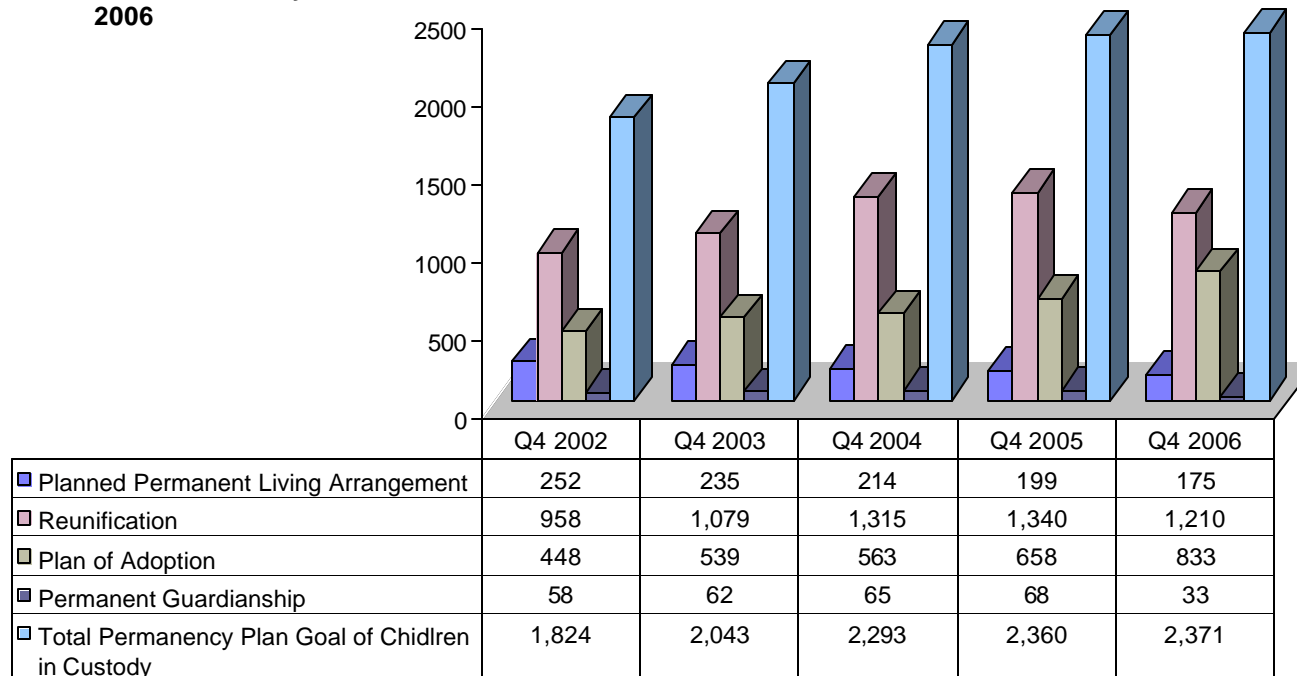

Permanency Plan Goals of Children in Custody on December 31, Annually 2002-2006



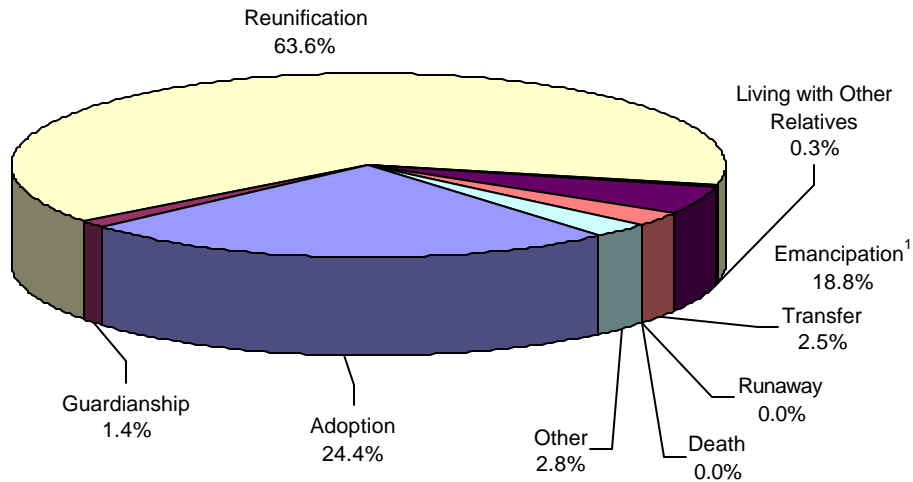

Exit from Foster Care During 4th Qtr 2006

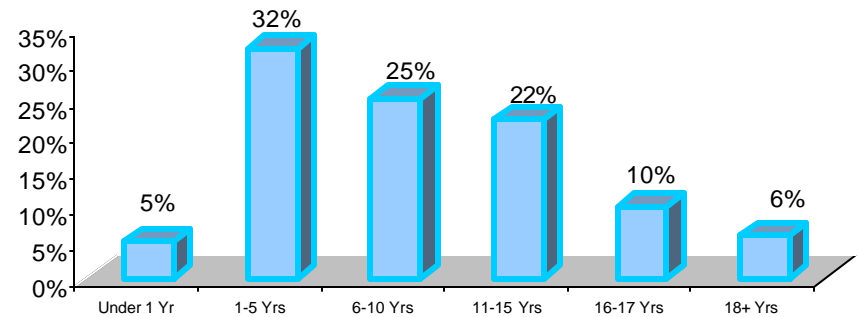

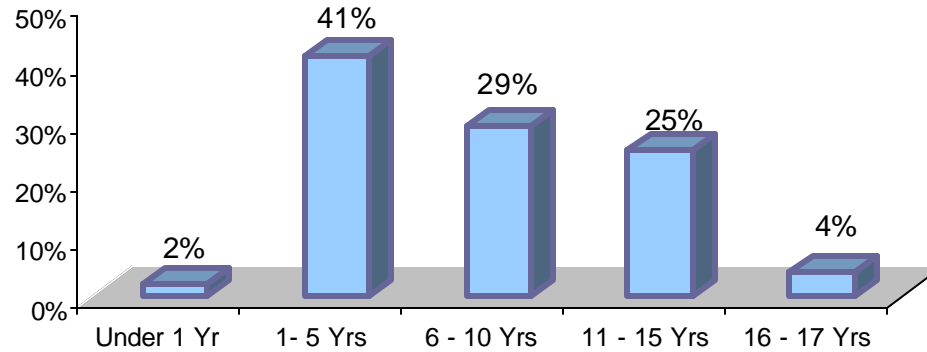
Age of Children in Foster Care as of December 31, 2006

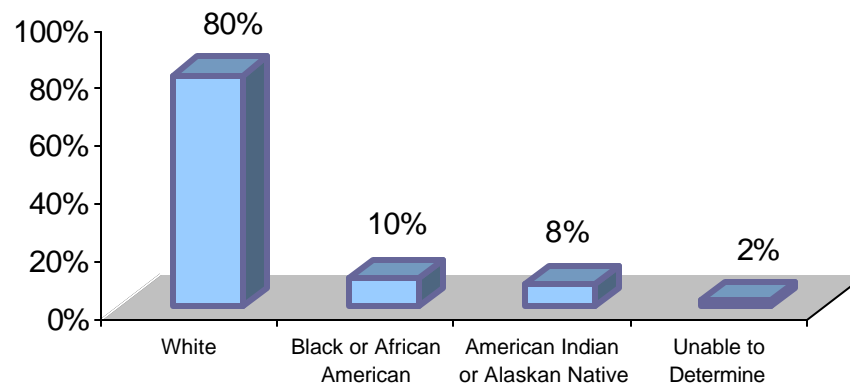


DEMOGRAPHICS OF CHILDREN WITH A PLAN OF ADOPTION FOR FOURTH QUARTER 2006

Legal Statistics

During the fourth quarter of 2006, 909 children had “adoption” as a permanency goal. As of December 31, 2006, 374 children were legally freed to be adopted. Of those legally freed, 107 children were in adoptive family homes and had an adoptive agreement signed and in effect.

Of the 909 children with adoption plans 59% are of Hispanic ethnicity, with 37% Non-Hispanic ethnicity, 4% are unknown.

Gender

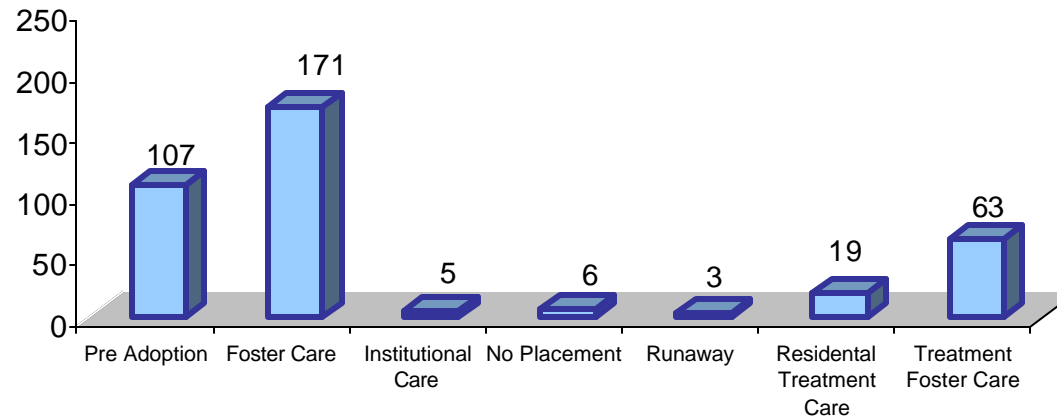
The gender distribution of children with adoption plans is 55% being male and 45% being female.

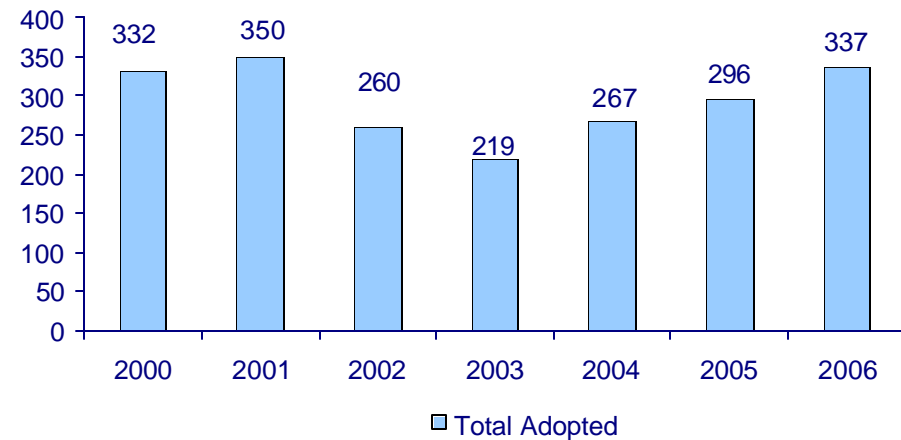

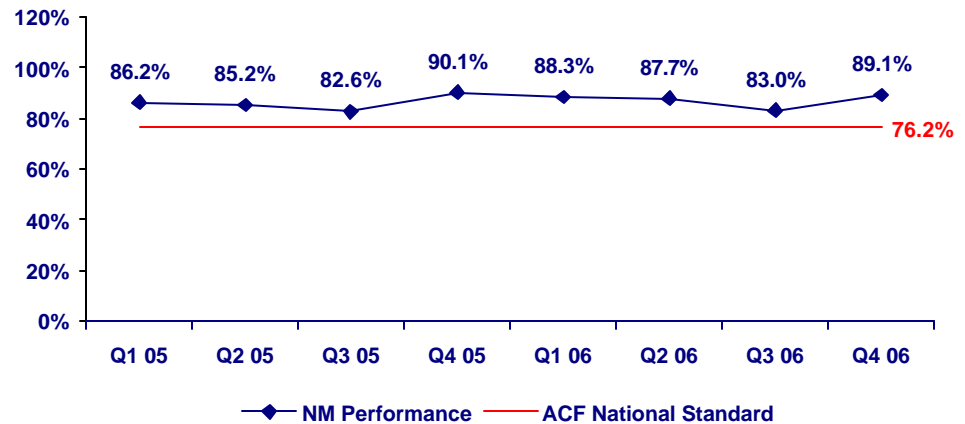

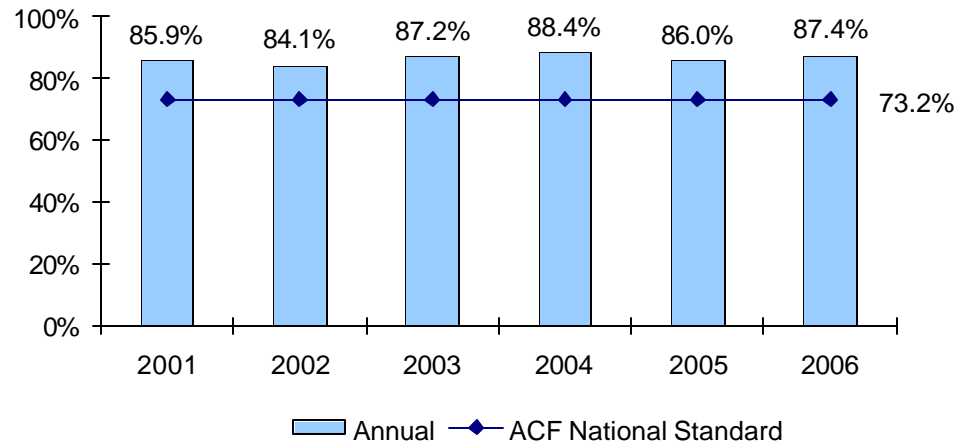

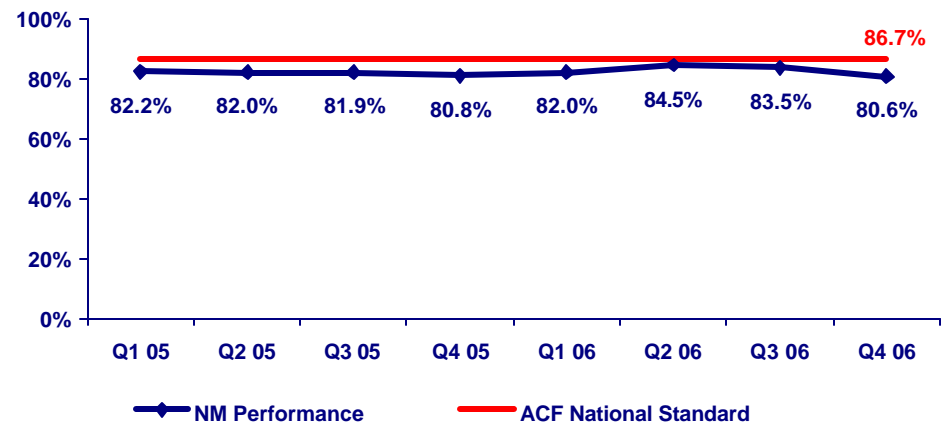

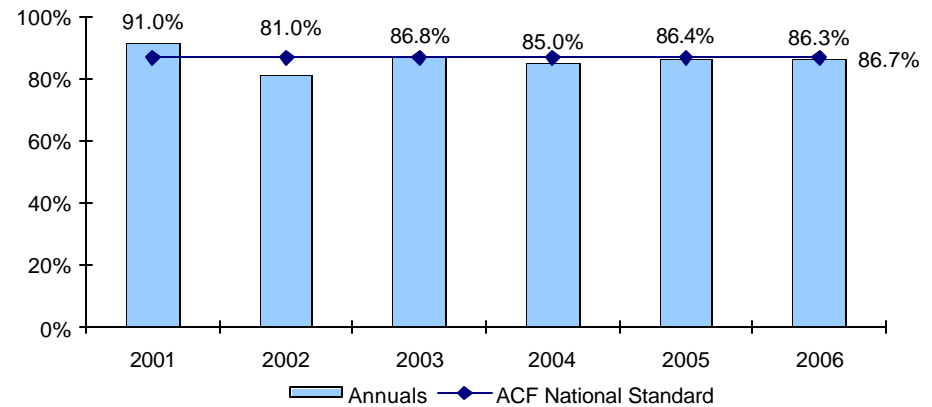

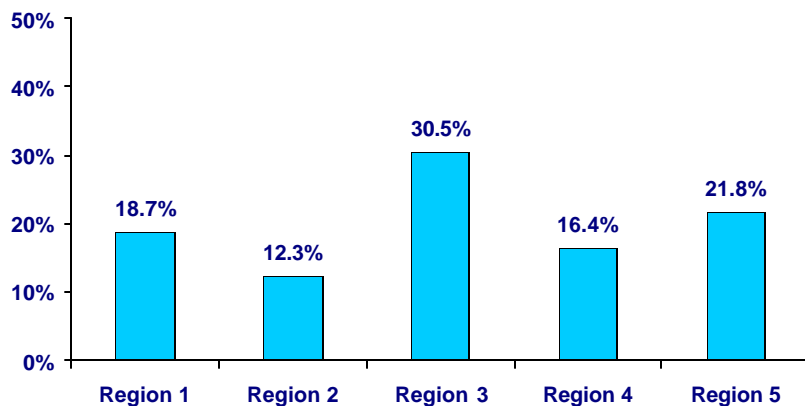

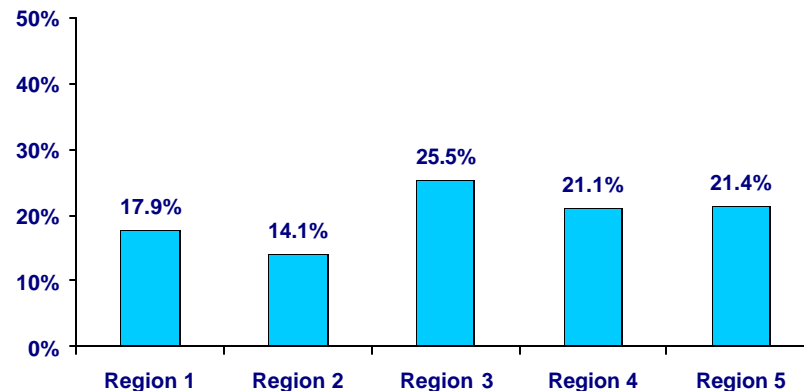
REGIONAL COMPARISON PERCENT OF STATEWIDE TOTALS OCTOBER - DECEMBER 2006

CPS Reports of Abuse and Neglect¹



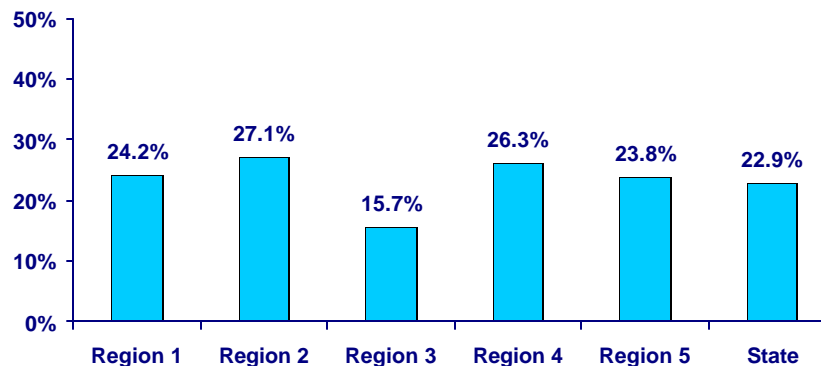

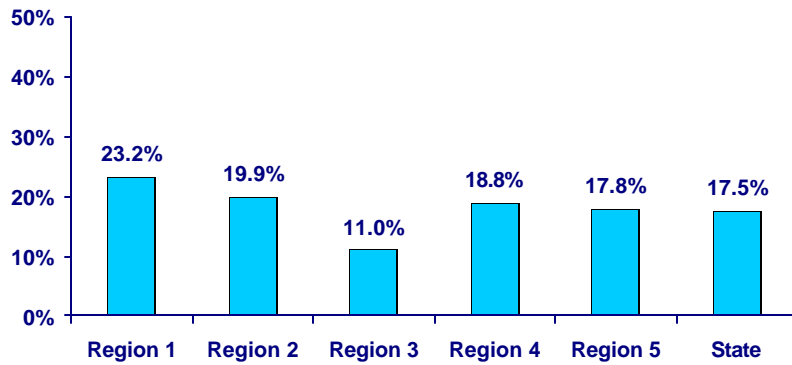
Total Substantiated Allegations³



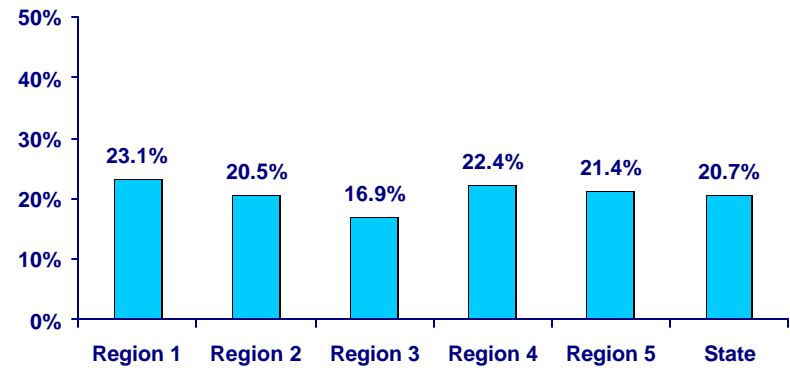

REGIONAL COMPARISON PERCENT OF STATEWIDE TOTALS OCTOBER - DECEMBER 2006

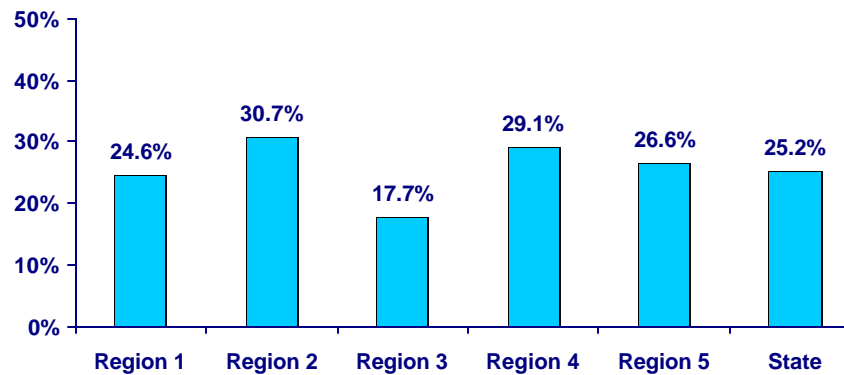
Substantiated Physical Abuse¹



Substantiated Sexual Abuse¹



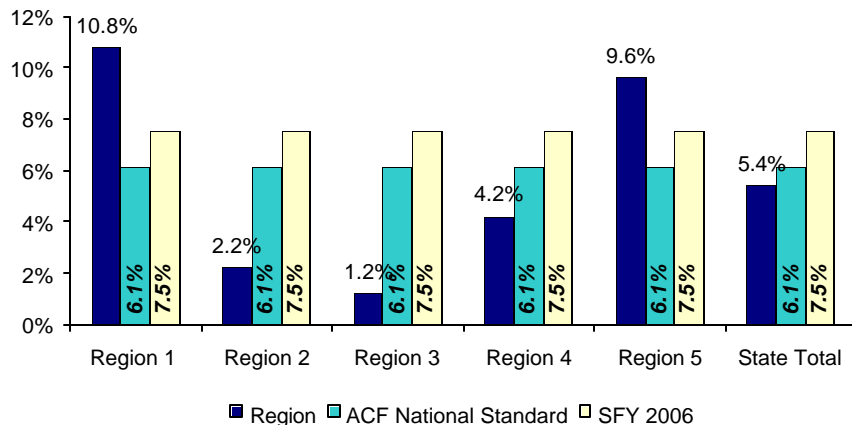
Substantiated Physical Neglect¹



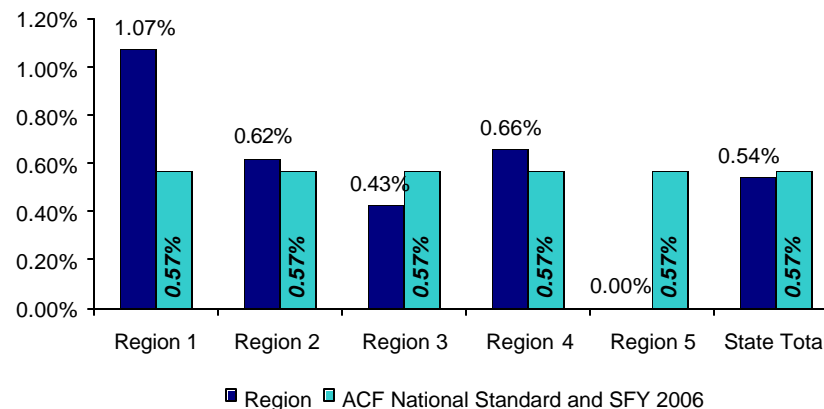

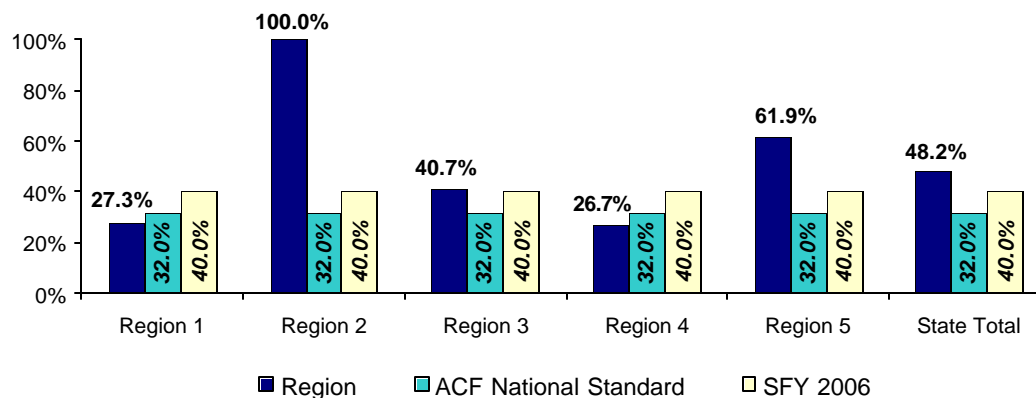
Percent of Recurrence of Substantiated Maltreatment Within 6 Months of a Previously Substantiated Report of Maltreatment¹

Percent of Children With a Finalized Adoption Within 24 Months of Entry into Care¹

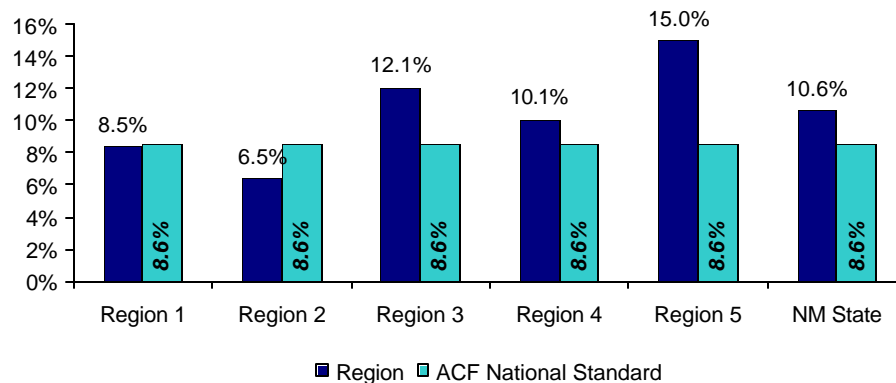

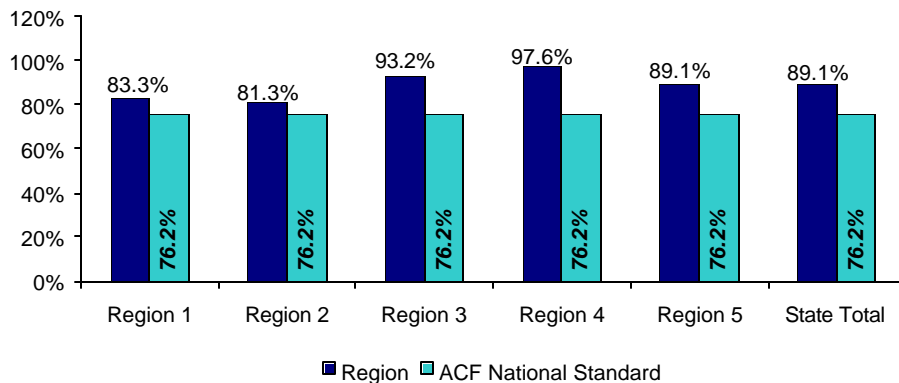

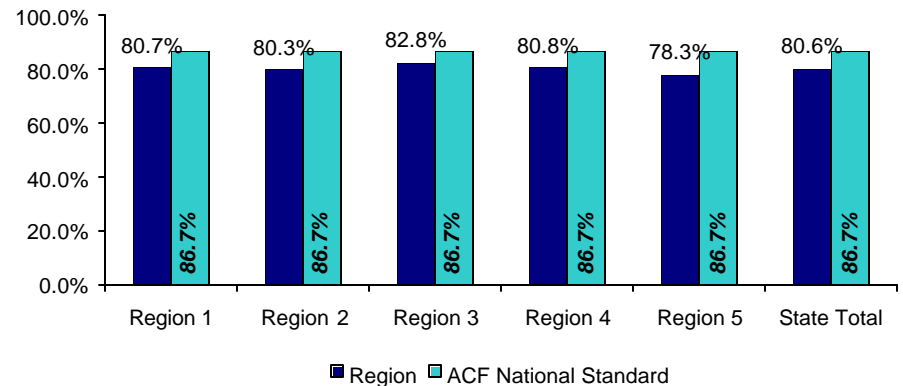
Percent of Children Reentering Care Within Twelve Months of A Prior Episode ¹
