




National Child Abuse and Neglect Data System (NCANDS) Safety Measures




Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%




Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%




Children in Care with Incarcerated Parents







Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%


Percent of Children in Care with Incarcerated Parents as a Condition of Removal Harding County




Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%





Children in Care with A Goal of Reunification Point In Time September 30, 2009 Luna County N = 24










Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%




Trends of Absence of Maltreatment in Foster Care National Standard = 99.68%






Trends of Absence of Recurrence of Maltreatment Within 6 Months of a Previously Substaniated Report of Maltreatment National Standared = 94.6%


#### Permanency Plan Goals of Children In Custody Qtr 1 SFY 2010








